#### REMINDERS

- Use Wufoo not email to submit your protocol:

  All types of protocol submission are required to be submitted using the appropriate Electronic Application Form in Wufoo. Emailed protocol submissions will be returned. Links to the electronic application forms can be found in the instructions at the top of each submission form.
- To speed up IRB review, make sure your submissions are complete and contain all information. When completing your Research Plan use the Research Plan Guidance document to ensure you provide all the information the IRB requires when making a determination or approval.
- When submitting documents, please use the <u>original</u> format of the document. The IRB does not accept google format or MSWord documents reformatted as a pdf. document.

As always, the use of the most current version of IRB documents (found on the IRB website) will improve the speed of the IRB review process. This allows researchers to receive an IRB decision and start research activities sooner.

## Q:I would like to conduct research using the students, as subjects, in the class I teach. Can I do this?

**A:** Research with one's own students inherently challenges the subject's "voluntariness" due to the power difference between students and instructor. Students may feel as though they have to participate or risk having their non-participation impact their grade or relationship with the professor. The IRB understands that real coercion is rare in research, but the perception of coercion potential can be a problem in obtaining voluntary informed consent. For this reason, the IRB has taken the position that **instructors should not use their own students as subjects in their research if it can be avoided**.

The IRB recognizes, that in some situations, it may be acceptable to use one's own students to conduct research. Special study design methods must be used before the IRB can approve this type of research.

- An independent third party must be part of the recruitment, consent process and data collection, if applicable. The
  instructor must not conduct the recruitment, consent, or data collection of *identifiable information*. The third party
  may or may not be required to be listed as a study team member. The instructor must be blinded to which student's
  are participating until student-instructor relationship has ended.
- Recruitment & Informed Consent: Risks associated with coercion, privacy and confidentiality must be minimized by using mechanisms to address these issues. If student records will be accessed, FERPA regulations apply and a signed consent form is required.
  - Consider the use of general announcements for recruitment (Blackboard posting/flyers/listserv.emails)
  - For survey/questionnaires use of an anonymous link to Qualitrics in recruitment materials. You may collect data anonymously or identified. If identified, only the third party may have access to the identifiable information. This is useful for longitudinal studies allowing the third-party to provide the investigator with the research data/information in a de-identified or coded manner until the student-instructor relationship ends.
- 3. Per federal standards, students must always be able to withdraw from participation.
