

American Rescue Plan Act (ARP) - HEERF III Reporting: Student Portion

Introduction

The American Rescue Plan Act of 2021 was approved by Congress and signed into law on March 11, 2021. Similar to the two previous phases, a portion of the funding will be used to provide emergency grants to students who may be struggling financially during the COVID-19 pandemic. Institutions who received HEERF I grant funds under the CARES Act were not required to submit an application for the HEERF III grants. The Department of Education will make supplemental awards to Campbell's existing Student Aid Portion. Campbell University is required to provide regular reporting to the U.S. Department of Education (ED) on the use of funds authorized by these acts.

Acknowledgement of Certification, Agreement, and Assurance

Campbell University acknowledges receipt of the ARP funds. Under the ARP (a)(1) program, as authorized under section 2003 of the ARP, the amount each institution must use for financial aid grants to students is determined by calculating the sum of 50 percent of the amount each institution receives under the formula factors in CRRSAA section 314(a)(1)(A)-(D).

Award Information

Campbell University received \$11,636,763 in ARP – HEERF III funding on May 19th, 2021. \$5,936,944 of these funds must be distributed to students as an emergency financial aid grant.

Funds Distributed to Date

Phase 1: Total amount that has been distributed to students during Phase 1 as of September 30th, 2021: \$352,550

Student Eligibility – Estimate

Phase 1: The estimated total number of students eligible to receive an emergency financial aid grant: 521.

Emergency Financial Aid Grant Received

Phase 1: Total number of students who received an emergency financial aid grant: 521.

Awarding Methodology

Phase 1: Students that were affected by COVID-19 and were enrolled in summer 2021 courses. An email, which included an application link, has been sent to all students enrolled in summer 2021 courses. Students that were affected by COVID-19, enrolled in summer 2021 courses, and complete the required application will be reviewed. The application for Phase 1 closed on August 20th, 2021

Additional Instructions:

Campbell University is directed by ARP guidance to prioritize students with exceptional need. As noted in ARPA guidance, exceptional need is “students who receive Pell Grants or are undergraduate students with extraordinary financial circumstances.” Other types of exceptional need could include students who may be eligible for other federal or state need-based aid or have faced significant unexpected expenses (ex. loss of employment, reduced income).

Per the Department of Education institutions should prioritize domestic students, especially undergraduates, in allocating the ARPA funding.

Campbell University ARPA emergency relief funds will be awarded in multiple phases.

Funds were disbursed to students through their student account which served as a pass-through vehicle. CRRSAA/HEERF II recipients enrolled in electronic refunding received funding through an electronic deposit to their bank account. Checks were mailed to recipients, not enrolled in electronic refunding.
