Note on New York: NY updated its PT educational requirement effective October 25, 2024 (Ch. 594, Laws of 2023) — now requires a doctoral degree in physical therapy. Campbell's DPT program meets this requirement; no change to determination needed, but NY entry should be reviewed to confirm regulatory basis note reflects the updated law.
