

Academic Year 2026 - 27**Semesters: Fall 26, Spring 27, Summer 27****Bill Clearance Schedule (Main Campus Undergraduate Traditional Courses)**

Bill Clearance requires completion of the following before the final day to complete Bill Clearance.

1. SFRA= Student Financial Responsibility Agreement
2. SFCI= Student Financial Check-In
3. Financial aid to satisfy all charges must be in place with credit based loans approved and required actions for aid to disburse to your student account completed.
4. Any remaining balance, after financial aid must be paid in full or by enrolling in a payment plan option and making the first payment.

This schedule is specific to main campus undergraduate classes only.

MCUG students taking online classes must receive bill clearance by noon to avoid online course delete.	Wednesday, August 5, 2026
Last day for resident students to obtain Bill Clearance to ensure uninterrupted move-in day. Resident students must obtain Bill Clearance before occupying university housing. New students not cleared by August 12 must visit Student Financial Services to obtain Bill Clearance on move-in day (Saturday, August 15). Returning students move in Sunday, August 16. Returners not cleared by August 12 must delay move-in and visit Student Financial Services during business hours (Mon.-Fri., 8:30 a.m.-5:00 p.m.) to obtain Bill Clearance.	Wednesday, August 12, 2026
Last day for pre-registered students to complete Bill Clearance Requirements MUST be complete by NOON to avoid a registration drop. Students not completing Bill Clearance requirements by NOON will enter the purge process. Students purged will need to obtain Bill Clearance before additional registration activity for the semester will be allowed.	Monday, August 17, 2026
First Day of Class. Must complete the SFRA and SFCI. Financial arrangements should be in place. (Registration hold will be placed on all accounts not cleared.)	Wednesday, August 19, 2026
