Program description

The Master of Accountancy (MAcc) program is the only program in the nation that provides graduates with the educational requirements for the Certified Financial Planner (CFP)® exam and the Uniform Certified Public Accountant (CPA)® exam. This combination of academic and professional credentials will serve a population of students who aspire to stand out among their peers, who favor a differentiated educational experience and wish to develop the knowledge, skills, and abilities that will enable them to take their career to the highest level.

The Campbell MAcc program provides students with a unique educational opportunity and a truly innovative curriculum that will establish the foundation for a successful career in accounting. Courses are offered in eight-week terms in the evening exclusively at Campbell’s Raleigh campus in downtown Raleigh.

The Master of Accountancy program leverages the academic expertise and professional experience of highly qualified faculty with years of experience in the accounting and financial planning professions.

Downtown location & flexible format

The MAcc program is designed to meet the needs of students who want to earn the MAcc degree but prefer a program that allows the flexibility needed for busy adults. Offered exclusively at Campbell’s Raleigh campus in downtown Raleigh, students may complete their scheduled course work in 12 months or may elect the optional two-year program cycle, completing the degree in 24 months. The curriculum begins in mid-August each year. Courses are taught in eight-week terms during the evenings. Each course meets one night per week from 6 to 10 p.m.

Admission Qualifications

1. A bachelor’s degree from an accredited institution of higher education
2. Demonstration of undergraduate-level competencies in the following areas:
 - a. Twenty one (21) hours of undergraduate accounting courses comprised of the following: six (6) hours of intermediate accounting and three (3) hours each of taxation, business law, audit, cost and statistics. This requirement must be met by completing and passing undergraduate courses in each of the subject areas. Such courses may be completed at any accredited college or university.
 - b. Three (3) hours each in economics and corporate finance. This requirement may be satisfied in a variety of ways.
3. A minimum grade point average of 3.0 on a 4.0 point scale on all undergraduate work.
4. Applicants to the MAcc program must submit either a GMAT, GRE or LSAT standardized test score. Scores more than 5 years old are not accepted. Applicants meeting certain work experience and education requirements may be considered for a GMAT/GRE waiver.

Applicants with GPA or test scores below the preferred criteria may still be considered on a case-by-case basis.



Apply Now

1. Complete the online application at business.campbell.edu/graduate-programs/apply/.
2. Attach a current resume to your online application.
3. Describe how personal experiences have shaped your academic and career goals and highlight how the Master of Accountancy program will advance them. What experience best illustrates your ability to meet the rigors of the Master of Accountancy Program? (1-2 pages in length)
4. Submit official copies of transcripts from all universities attended via online application.
5. Submit three (3) professional letters of recommendation via online application.
6. Take the GMAT (7G7-0L-18) or GRE (8567) and have score report sent to the School of Business Graduate Admissions Office.

Classes begin mid-August.

Additional requirements for international students can be found on our website. International applicants should apply at least one month prior to the program start date.

We operate on a rolling admission schedule. The Admissions Committee evaluates applications when completed and usually notifies students of their decision a few weeks after the application is submitted.

Completed applications are accepted until the first day of class, however applicants are strongly encouraged to submit a completed application at least 5 business days prior to the program start date.
