The MDiv/MBA degree is offered to those who desire to complement their theological education with a foundation in business administration. Those who aspire to serve as pastors, associate pastors, church administrators, or staff members may pursue this degree to gain greater business management training along with their theological education.

### MBA Dual Degree Admission Criteria

- Bachelor's degree from an accredited institution of higher education
- Minimum GPA of 2.8 on a 4.0 scale on all undergraduate coursework
- Undergraduate prerequisites in Accounting, Economics, & Statistics
- Application and acceptance into the relevant partner program

### MBA Dual Degree Application Materials

- Online Application Form with \$48 application processing fee
- Current Resume
- Essay
- Copy of partner program admission application (transcripts and letters of recommendation will be used as part of the MBA application)

### **How it Works**

Students enrolled in the MDiv/MBA Dual Degree program complete the full Core Curriculum for each individual degree. The time and money saving benefits of the dual degree option are realized through the sharing of courses across the elective curriculum of both programs. MBA courses are used to satisfy MDiv elective course credit, and MDiv courses are used to satisfy MBA elective course credit, resulting in students taking 21 credits hours less than would be required if each degree was pursued separately.
